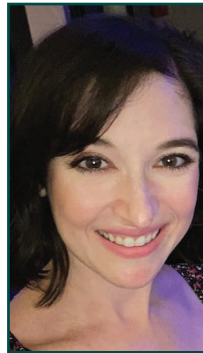

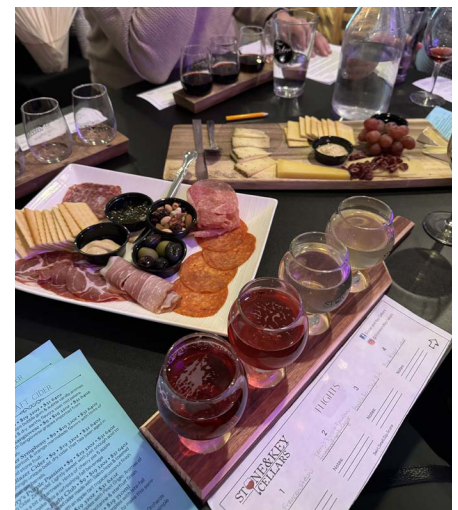

Women's Center of Montgomery County

Since 1976 the **Women's Center of Montgomery County (WCMC)** has continued to grow services to meet the needs of survivors of Domestic Violence. WCMC has Medical Advocates in 3 Montgomery County hospitals, has 7 office locations, which includes our Protection from Abuse Office in the Montgomery County Courthouse. The Women's Center also provides a safe space for young adults to discuss healthy relationships on our Teen Text Line.

Our purpose is to be where we can best aid those suffering from domestic violence.

As an organization WCMC assisted approximately 4,000 individuals from Montgomery County last year, 569 of these survivors were men. These are members of our community, our sisters, brothers, friends, co-workers, parents.

1 in 3 women, 1 in 4 men, and nearly half of LGBTQ+ individuals will experience domestic violence in their lifetime. Last year 101 victims in Pennsylvania died at the hands of their abuser, here in Montgomery County 4 of our residents lost their lives to domestic violence.

Organizations such as ours work each day to provide support and services to those who need them to safely leave their abuser. Many of these survivors have children, pets, or may be unemployed which only adds additional layers of worry to an already frightening situation.

In 2016 the Pennsylvania Legislature passed the felony strangulation law. If an individual strangles or attempts to strangle an intimate partner or a member of their household it is graded as a felony. Under prior law, an accusation of choking or strangulation with minimal injuries would have been charged as a simple assault or harassment offense. Strangulation is an indicator of rising violence. According to the Strangulation Institute, a victim of strangulation is 750 times more likely to die by gun violence from their abuser. These statistics are staggering but vital information to victims.



This past year WCMC created the High Risk Assessment Team to share this information with survivors, law enforcement, medical practitioners and our district court judges.

Currently there is no resource to identify a convicted abuser, other than the strangulation charge and as stated before this is an escalated action. Many victims live years with coercive control, being financially, emotionally and verbally abused. Often, once an abuser rises to the physical assault level it falls to the victim to find the internal strength to plan a safe way out and a place to hide. Organizations like ours are here to help. Community awareness of these programs are vital to get help to those in need.

"In the last 10 years, more than 1,400 victims and perpetrators have died from domestic violence-related incidents in Pennsylvania." (PCADV). That is more than 100 victims each year. It is imperative that the healthcare community network with a local DV agency and be educated about domestic violence so that we can get victims the resources and information they need to stay safe and not become a statistic.

He has served as a Dental Director for Cigna Dental and was the Texas Dental Director for United Concordia Dental Insurance. While at United Concordia, he oversaw the administration of the dental portion of the Texas Children's Health Insurance Program. He was also employed as the Director of Quality Assurance for South Texas Dental. He is now the Director of Third Party Programs and Insurance for Smile Source, a group dedicated to preserving the elite business of independent dental care, as well as, the Chief Dental Officer for First Pacific Corporation. Dr. Osborne lectures nationally on a variety of in demand topics including medical billing, sleep dentistry, and laser dentistry.

AM: OFFENSIVE DENTISTRY

Let's face it, sitting through a lecture about dental caries or caries risk assessment isn't appealing (in fact it sounds downright boring). However, the science of clinical cariology is beginning to have an impact on restorative techniques and technology. Streptococcus mutans has more to fear than a rheostat, now that we're armed with salivary diagnostics and bioactive materials. At the end of this course, participants should be able to:

- Intervene medically in the caries process
- Control patient caries risk with focused therapeutics
- Design restorations to minimize recurrent decay
- Improve the prognosis of restorative treatment

Dr. Brian Nový is the Chief Dental Officer of the Alliance Dental Center, Massachusetts Public Employees Fund with faculty appointments at Harvard School of Dental Medicine and Western University. His awards include the Academy of General Dentistry Weclaw Award, The ADA Evidence Based Practice Award, The AADR/IADR Gies Award, and the ADA Adult Preventive Care Practice of the Year. He served on the ADA Council of Scientific Affairs from 2010 to 2014, and as President of the CAMBRA coalition. In 2016 he was appointed the Consumer Advocate, United States Food and Drug Administration Dental Products Panel.

THE ART OF DENTAL THERAPEUTICS

Better Medicine, Better Dentistry

If the term “relevant and useful pharmacology” sounds like a program you would like to avoid – think again! Providing dental care to anxious, fearful and medically complex patients continues to be a major challenge facing oral healthcare providers. Now more than ever, dental professionals are faced with the additional challenges of treating these patients’ oral health needs in the face of polypharmacology, drug interactions, potential illicit drug use and multiple chronic conditions. Imagine if all of this could be made much easier by just going back to the basics.

Have you ever had to face the prospect of treating a medically-complex patient? Have you ever had a patient needing treatment for a dental emergency who has more than one underlying chronic disease? What about your patients of

record who are on more than five medications? Now what if these same patients are also experimenting with cannabinoids or illicit drugs? How does the use of marijuana, cocaine, methamphetamine, crack, Salvia divinorum, khat bush, or designer drugs such as MDPV change your treatment plan?

This course will review the pharmacology and current state of medicinal marijuana as it relates to oral health care.

A survey of patients with heart disease, diabetes, psychiatric disorders, and/or hypertension found that 79% were taking supplements concurrently with prescription medications. Among those with cardiac disease, 20% reported regular use of herbals. If this raises your blood pressure, then you need to take this course.

This interactive program is designed for dentists, hygienists and dental assistants, case studies will augment the delivery of key points and a problem-based learning approach is encouraged so that each participant’s questions are addressed.

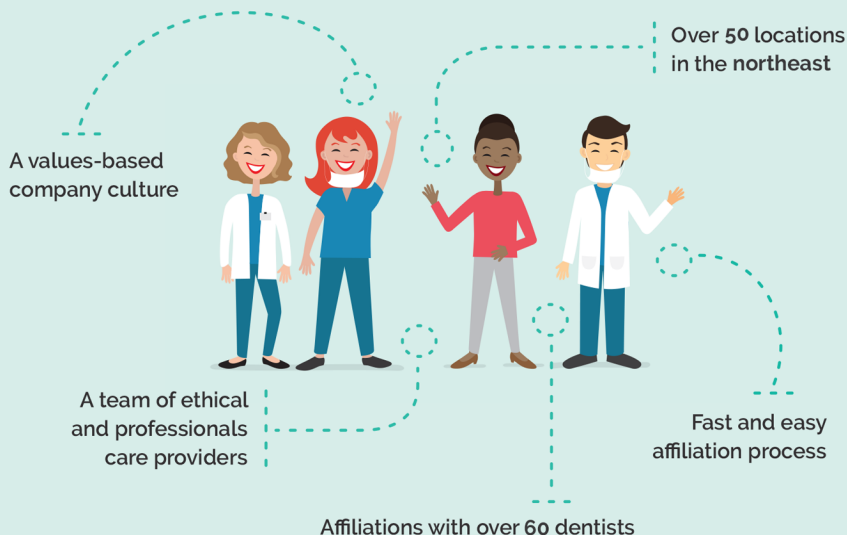
