
President's Message

Respectfully, do you know your neighbour? Not the person next door at your home address, but professional neighbour? vour The dentists, hygienists, orthodontists who operate in the same locale as you, and service the same patients that you do? You would more likely refer to them as your competitors and, while they technically are, I think the time has come that we rethink the way we relate to each other as dental professionals if there is to be a bright future for any of us here.

The truth is that in the market for dental services, we aren't that different. We have similar goals of building our client bases, running strong practices, thriving in our profession. But we sabotage ourselves by leading divisiveness: with when refuse to communicate with each other, when we throw darts at one another, when we turn our clients against our neighbours, and treat our dignified field as though it is a cut-throat industry where hostility is the only way to survive.

In polling a sample of dentists, both general and specialist, a common experience expressed was having patients return with unreasonable and egregious criticisms levied against their work from other dentists in the neighbourhood. Harsh judgement in the absence of a conversation, without reference to their treatment plan, and without any consideration for procedural differences that understandably exist between practitioners.

When did we develop the idea that the only way to win a client was to denigrate the work of another? Why do we prefer to share our uninformed and rash judgments with the patient, before picking up the phone to first discuss our concerns with the dentist next door? Why are we allowing dental hierarchy to dictate the level of respect—or disrespect we give each other? Where is our neighbourly courtesy? We are all members of the dental fraternity, but we are exposing ourselves to lawsuits with these acts of incivility.

While dental malpractice claims are considerably less than for physicians, these claims cost us tremendously in settlement/suit payouts, loss of productive work hours, stress, and reputational damage. We are creating a litigious neighbourhood because our lack of professionalism and communication is fostering an environment where patients distrust and second-guess our advice and our work. Do we really think this is in anyone's best interest? Are we still focused on successful maximizing patient outcomes or on maximizing the extraction of client funds? There are many ways to make our practices more efficient and financially sound without tearing each other down and tearing apart the gums and pockets of our patients.

The reality is that as practitioners in an already gruelling profession, we are operating in a time of great challenge. We are increasingly dealing with emotionally-charged patients with no shortage of tragic post-COVID stories; overwhelming demand and challenges being faced

by the support teams on which we rely; and the continual lowering of dental reimbursements from insurance companies; finally, add on unnecessary friction and potential legal action—at the hands of your neighbour? Aren't we in this together?

This is the time we should come together and support each other; to weather the storms and protect one another. Just as in dental school, we succeeded because we listened, shared, encouraged, and built up each other. Likewise, we could do so much better for our practices and our clients if we are mature about communicating, collaborating,

knowledge-sharing, and referring patients to your neighbours with expertise in an area that is not your strength. There will always be lines of differences between us related to our philosophies, specialities or techniques, but differences don't preclude the decency of speaking respectfully and professionally to and about each other. We can do better, together.

Admittedly though, I didn't enter the field to be a crusader for building up the dental community. I spent the last 20 years of my career, like most of you, working in my own silo, trying to figure out how to build a successful practice through

my own excellence and ingenuity. But I didn't need to reinvent the wheel, and neither do you. Through mentorship, supportive amazing immersive experiences at the PA Leadership Academy, I have seen and grown so much. There is an abundance of expertise and resources out there waiting for you to tap into: simple solutions, better workflows, systems and methods you can employ to achieve more profit while doing less. Believe it or not there is enough for all of us to thrive, but it begins with knowing and respecting your neighbours as teammates, not competitors.

In 2006, Dr. Yepes completed a Master in Public Health (MPH), and in 2011 a Doctoral

Degree in Public Health (DrPH) both with emphasis in Epidemiology at the University of Kentucky College of Public Health. In 2008, he completed a residency program in Dental Public Health at University of Texas, Baylor College of Dentistry. Finally, Dr. Yepes completed a residency program and a master in pediatric dentistry at the University of Kentucky in 2012.

Dr. Yepes is board-certified by the American Boards of Pediatric Dentistry, Oral Medicine, and Dental Public Health. He is an active member of the American Academy of Pediatric Dentistry, American Academy of Oral Medicine, American Academy of Oral and Maxillofacial Radiology, Indiana Dental Association, and American Dental Association. Dr Yepes is a fellow in dental surgery from the Royal College of Surgeons at Edinburgh. He is a member of the editorial board of Oral Surgery, Oral Medicine, Oral Pathology, and Oral Radiology. Dr. Yepes is also the associate editor of the Journal of the American Dental Association (JADA)

Session 1: Act 31 Child Abuse Recognition & Reporting - Dr. Angela Stout

PDA's program, *Child Abuse Recognition and Reporting for Dental Professionals*, is approved by the Department of Human Services and the PA State Board of Dentistry and will fulfill Act 31 mandatory CE requirements for licensed dental professionals (dentists, hygienists and EFDAs).

Course Objectives:

- Understand categories of child abuse as defined by the Child Protective Services Law.
- Recognize universal child abuse indicators.
- Recognize clinical and intraoral pathologies of physical and sexual abuse.
- Understand the legal responsibilities as mandated reporters.
- Know when, how and where to report suspected abuse, and what happens after a report is made.
- Understand the protections for reporters and penalties for failure to report.

ATTENTION: Attendees will be asked to provide their full name, license number, date of birth and the last 4 digits of their social security number at the course.

PDA will transmit this information to the state to verify that you completed the course.

Session 2: Pain Management Alternatives & Identification of Addiction - Dr. Michael Kaner

The lecture will fulfill the Act 124 of 2016, CE requirement for dentists who have a current DEA registration or use another DEA number (as permitted by law) to prescribe controlled substances. Pain management, identification of addiction and the practices of prescribing opioids will be discussed. 2 CE credits required for dentists who hold a DEA registration or use another DEA number to prescribe controlled substances. 2 CE credits also appropriate for hygienists and dental assistants.

Course Objectives:

- Understand the pathology and physiology of pain and addiction.
- Suggest alternative therapies for pain management.
- Assess treatment programs and understand how to refer for treatment.
- Cite the history and politics of opioids.
- Be aware of doctor prescribing habits.

Session 3: OSHA Safety and Infection Control Training (2 hours) - Karen Pass

This seminar discusses several OSHA requirements: the Hazard Communication Standard, the Bloodborne Pathogen Standard, and the General Industry Standard (including COVID-19 updates, injury/illness management and reporting, fire and life safety/Emergency Response Plans, workplace violence, and other topics related to health and safety in the dental workplace), and the CDC Guidelines for Infection Control in Dental Healthcare Settings.





Roopali Kulkarni, DMD, MPH is a board-certified oral medicine specialist. She is an Assistant Professor of Oral Medicine at the University of Pennsylvania School of Dental Medicine and serves as the Assistant Director of the postgraduate oral medicine residency program. She obtained both her Doctor of Dental Medicine (D.M.D.) and Master of Public Health degrees (M.P.H.) from the University of Pennsylvania. She completed her postgraduate residency training in Oral Medicine at the Hospital of the University of Pennsylvania. She currently teaches predoctoral and postdoctoral students clinically and didactically. She was the 2022 recipient of the Penn Dental Medicine Earle Bank Hoyt award for dedication and excellence in teaching. Her scholarly activity focuses on research within oral medicine and public health. She is an active researcher in the World Workshop on Oral Medicine and is a Senior Fellow at the Penn Leonard Davis Institute of Health Economics. In addition to her faculty responsibilities, she treats patients within the University of Pennsylvania Health System and is the Section Chief of Oral Medicine at the ChristianaCare Hospital System. Dr. Kulkarni has maintained active involvement in organized dentistry.
